

Financial Markets Daily

Main drivers for the financial markets today...

- Stock markets mixed –with Europe and US futures negative, but Asia positive– the USD weakens, and government bond yields a lower, reacting to US inflation and employment data, with mixed signals for the Fed
- In this sense, inflation in September in the US was marginally above expectations at 0.2% m/m, with the core at 0.3%. As such, the annual metric for the headline came in at 2.4% (previous: 2.5%), with the core at 3.3% (previous: 3.2%). Also in the US, jobless claims were published, increasing to 258 thousand. In Mexico we await Banxico's minutes later on
- In China, the PBoC set up a swap facility aiming to provide liquidity to investors who may plan to buy stocks, this as an additional stimulus measure. It should be noticed that officials from other agencies have emphasized that on Saturday they will present additional fiscal measures, trying to reverse recent losses
- In other news, in Florida, 3 million homes and businesses are reported to not have power due to Hurricane Milton impact. Damages and losses are expected to reach US\$60-US\$75 billion
- In the US presidential race, Donald Trump proposed eliminating income taxes for the roughly 9 million Americans living abroad

Equities

- Mixed movements in the stock markets, with investors waiting to see if corporate results are solid enough to show strength in the economy to maintain highs and assess how accommodative the central bank cycle would be
- Based on the above, US futures are below their theoretical value with the Nasdaq and S&P 500 down 0.1%, after reaching another high yesterday. On its side, the Eurostoxx slightly negative (-0.1%), affected by companies in the technology and industrial sector. Finally, Asia closed higher, with the Hang Seng up 3.0% and the Nikkei up 0.3%
- In the corporate sector, Delta released its 3Q24 results, which did not meet sales and earnings expectations, suggesting a slower recovery in the sector. Meanwhile, insurance stocks were rising prior to the market opening after Hurricane Milton weakened to a Category 3 storm

Sovereign fixed income, currencies and commodities

- Positive balance in sovereign bonds. Ten-year rates in Europe decrease by 1bp on average, while the Treasury curve shows a slight steepening bias with gains of 1bp at the short-end and an adjustment of +1bp at the long-end. Yesterday, Mbonos averaged losses of 4bps
- USD negative against G10 currencies, with JPY (+0.5%) leading the gains. In EM, performance is mixed, with ZAR (+0.7%) and PHP (-0.6%) at the extremes. The MXN appreciates 0.3% to 19.44 per dollar, mitigating some of the previous session's losses (-0.7%)
- Positive performance in commodities. Crude-oil futures rise nearly 1%, driven by ongoing tensions in the Middle East. Net positions in Brent increased by 139 million barrels last week, according to the Intercontinental Exchange Inc. Precious metals are up, with gold and silver rising 0.5% and 0.6%, respectively

Corporate Debt

- HR Ratings affirmed Consubanco's rating at 'HR A' with a Stable outlook, based on the stability of the bank's solvency profile as of 2Q24. It also maintains a stable delinquency rate with respect to the previous review, with an adjusted delinquency rate of 3.3%
- PCR Verum assigned Engen Capital long-term ratings of 'AA-/M' with a Stable outlook and short-term ratings of '1/M'. The ratings are based on its diversified portfolio and controlled delinquencies, maintaining sufficient credit reserves in the agency's opinion, coupled with its profitability, which has been improving in recent years and is currently good
