# Flash: With the biggest advance in the sector in June supported by nearshoring


Oma noted that in June total passenger traffic at the 13 airports it operates showed an increase of 13.6% y/y, slightly better than our estimate of 11.0%. The domestic traffic continued with a solid performance, rising 12.9% y/y; however, the greatest advance once again occurred in international traffic with an increase of 19.3% y/y. On the other hand, the company mentioned that two new routs began to operate during the month.

**Positive implication:** The evolution of traffic confirms the prospect of sustained and profitable growth, coupled with greater cash flow generation. This is further supported by the fact that Oma is the group that has the airport portfolio with the most exposure to destinations benefiting from nearshoring – of which Monterrey, which is the main one, was among those with the highest growth in the month–, which in our view should provide an additional boost to passenger demand. This reaffirm the company as <u>our favorite in the sector</u>. We will be looking forward for any updates it might share in its 1Q23 report next Friday, July 28, after the market closes.




