OPEC+: Unexpected global production cut of 1.66 Mbbl/d

- Yesterday, OPEC+ unexpectedly announced a voluntary production cut of 1.66 Mbbl/d, led by Saudi Arabia (-500 Kbbl/d) and Russia (-500 Kbbl/d), starting in May until the end of 2023. This action was also joined by Iraq, United Arab Emirates, Kuwait, Kazakhstan, Algeria, Oman and Gabon (See table)
- The decision was reaffirmed today at the Technical Monitoring Committee, noting that it is a precautionary measure to support energy market stability. Furthermore, it was clarified that these adjustments will be in addition to the global supply cut of 2 Mbbl/d established at the October 2022 meeting
- The decision took place amid a less optimistic outlook for prices due to increased concerns about economic growth triggered by high interest rates, turbulence in the banking sector and a slow reopening of China. This situation was reflected in a decrease in net long non-commercial positions in both WTI and Brent. In this sense, both references traded at intraday lows of more than a year of 70.3 \$/bbl and 64.3 \$/bbl during March and closed the quarter with losses of 7.2% and 5.7%, in the same order
- The price reaction was broadly positive, Brent and WTI closed at 84.9 \$/bbl (+6.5%) and 80.4 \$/bbl (+6.3%), respectively. However, OPEC+ decision could add inflationary pressures, forcing central banks to keep interest rates high for longer
- In this context, we continue to expect Brent to trade between 70 and 100 \$/bbl for the rest of the year, although we do not rule out upward spikes following OPEC+'s posture to keep prices high
- The next Ministerial Meeting and Joint Ministerial Monitoring Committee will be held on June 4th, 2023






